# Month to 31 January 2020

PIP announced an unaudited net asset value ("NAV") per share as at 31 January 2020 of 2,768.7p, an increase of 19.4p (+0.7%) from the NAV per share as at 31 December 2019. Valuation gains\* (16.3p, +0.6%), investment income\* (0.3p, 0.0%) and foreign exchange movements\* (5.8p, +0.2%) were partially offset by expenses and taxes\*\*\*\*\* (-3.0p, -0.1%).

PIP's valuation policy for private equity funds is based on the latest valuations reported by the managers of the funds in which PIP has holdings. In the case of PIP's valuation as at 31 January 2020, 96% of reported valuations are dated 30 September 2019 or later. A detailed description of PIP's valuation policy can be found on pages 100 and 101 of the 2019 Annual Report and Accounts.

At 31 January 2020, PIP's private equity assets stood at £1,428m, whilst net available cash balances<sup>^</sup> were £135m. The Asset Linked Note<sup>^^</sup> ("ALN") outstanding as at 31 January 2020 amounted to £65m. Undrawn commitments to investments stood at £490m as at 31 January 2020, calculated using exchange rates at that date. PIP's multi-currency revolving

credit facilities comprise a US\$163.0m facility and a €59.8m facility, which remained undrawn as at the month end.

PIP made four new investments during the month amounting to £9.5m in new commitments. This included a £4.5m co-investment, alongside Lovell Minnick Partners, to Charles Taylor, a leading international provider of professional services and technology solutions to the global insurance market
