**Month to 31 July 2021**

PIP announced an unaudited net asset value ("NAV") per share as at 31 July 2021 of 3,536.3p, an increase of 14.4p (+0.4%) from the NAV per share as at 30 June 2021.

In the month to 31 July 2021, valuation gains\* added +39.0p (+1.1%), investment income\* added +3.4p (+0.1%), foreign exchange movements\* were -23.7p (-0.7%), and expenses and taxes\*\*\*\* were -4.3p (-0.1%).

PIP's valuation policy for private equity funds is based on the latest valuations reported by the managers of the funds in which PIP has holdings. In the case of PIP's valuation as at 31 July 2021, 98% of reported valuations are dated 31 March 2021 or later, and 2% are dated 31 December 2020.

At 31 July 2021, PIP's private equity assets stood at £1,759m, whilst net available cash balances^ were £200m. The Asset Linked Note^^ ("ALN") outstanding as at 31 July 2021 amounted to £46m. Undrawn commitments to investments stood at £577m as at 31 July 2021, calculated using exchange rates at that date. PIP's multi-

currency revolving credit facilities comprise a US\$269.8m facility and a €101.6m facility, which remained undrawn as at the month end.

PIP committed £67.8m during the month to six primaries (£63.0m) and one co-investment (£4.8m). This included:

- A £20.6m primary commitment to Index Ventures Growth VI, a global growth equity fund.
- A £10.8m primary commitment to Advent Global Technology Fund II, a technology-focused fund investing predominantly in North America and Europe.
- A £4.8m co-investment alongside Providence Strategic Growth in Government Brands, a US-based provider of software solutions to government entities.
